Passengers' Agreement for Limousine Service

Appropriate conduct and behavior is required during the rendering of service. **When consumed by a minor, the consumption of alcoholic beverages is unlawful. There will be no alcoholic beverages** transported in the passenger compartment of the vehicle: alcoholic beverages, as well as any and all illegal substances, are prohibited in the trunk, or any other compartment of the vehicle. During the rendering of service, if at any time, any of the passengers are found to have in their possession, or have been consuming alcohol or illegal substances, or involved in illegal actions/behavior, **the service shall be terminated at once.** All monies paid to Provident Sedan & Limousine Service Services shall be forfeited, and a parent and/or **Police Officer shall be notified.** The Limo operator has the option of returning vehicle to the point of pick up, or ending the service at the point of the infraction. **Our drivers have the right to examine all bags or parcels** being placed into the vehicle, to determine if they contain any infraction substance.

If the interior of this vehicle sustains damage during service through this agreement, below signers' parents/guardians are held responsible for restitution.

During rendering of service, the limousine's divider screen will remain down.

All vehicles are non-smoking, regardless of age
